Chicago Energy Benchmarking and Disclosure Ordinance Passes

On September 11, 2013, with a vote of 32-17, the Chicago City Council passed the Energy Benchmarking and Disclosure Ordinance. This ordinance will require non-industrial buildings greater than 50,000 square feet to track their energy usage in Portfolio Manager. More details.
